# 6th Grade Initiative: Code of Conduct/Waiver Release

The YMCA is committed to providing a safe and welcoming environment for all members and guests. To promote safety and comfort for all, individuals are asked to always act appropriately when in our facility or participating in our programs. We expect persons using the YMCA to act maturely, behave responsibly, and respect the rights and dignity of others. Participants in the 6<sup>th</sup> Grade Initiative program and membership are expected to follow the same guidelines as other YMCA members.

## As a member of the 6<sup>th</sup> Grade Initiative Program, I will model the following guidelines:

**Initial** \_\_\_\_\_ I will consistently exemplify the four core values of Y character development: caring, honesty, respect, and responsibility.

**Initial** \_\_\_\_\_ I will speak in respectful tones, excluding the use of vulgar or derogatory language.

**Initial** \_\_\_\_\_ I will safeguard all personal items in a locked locker and do my part to create a safe environment for all. The YMCA of the Northwoods is not responsible for lost or stolen property. I know I can bring my own lock to secure my belongings.

**Initial** \_\_\_\_\_ I will complete the Youth Wellness Orientation prior to accessing the Wellness Center, which I can schedule at the Welcome Center.

**Initial** \_\_\_\_\_ I will access programs and program areas during the specified scheduled days and times.

**Initial** \_\_\_\_\_ I understand the Y reserves the right to suspend or terminate my membership privileges for inappropriate behavior at any time.

**Initial** \_\_\_\_\_ I am expected to follow the guidelines of the 6GI program.

## Additional Responsibility and Releases (Parent/Guardian Release)

**Initial** \_\_\_\_\_ **Code of Conduct-** The Y is founded on Christian principles and prohibits inappropriate behavior and conduct.
